North End BRA Large Projects – update on Lewis Wharf

An update will be given on Lewis Wharf by Sydney Asbury of Save Our North End Waterfront, including explanation of the DEP's ruling regarding buildability of the existing pile field (policy not specific to Lewis Wharf, but intended to apply to all MA waterfront developments to protect open waters). NEWRA has been asked by Save Our North End Waterfront to submit a letter of support of the DEP's ruling in advance of the expiration of the public comment period on 11/21/16. We will vote on member support for such a letter following the presentation.
