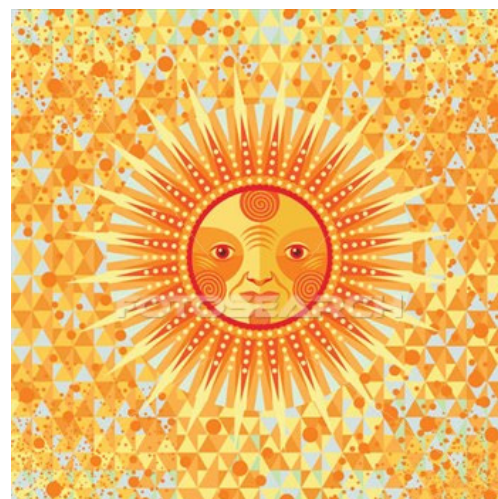

#### **North End BRA Large Projects – brief updates on 88 N. Washington and Parcel 9**

Larger projects in the City are managed by the Boston Redevelopment Authority and are governed by the BRA's "Article 80" process. The City Council's extension of the Urban Renewal Zones includes increased City Council oversight of BRA Projects.
