**180 Endicott Street. Simcha Weller, Manager, for the owner, 180 Endicott Street LLC,** has applied to the Board of Appeal to change the occupancy at 180 Endicott Street from three residential units to four residential units. The third and fourth floors have been used as one unit without being connected, and will now become two units. The plans show no change to Unit 1, a new kitchen in Unit 2, the addition of a bathroom and a new kitchen in Unit 3, and the addition of a kitchen and a new bathroom in Unit 4. Each apartment will have one bedroom. No floor area will be added, and there will be no increase in the number of bedrooms. One bathroom will be added, to provide one bathroom in each of the four units.

**5, 7 and 9 Jerusalem Place. Christopher Young, Manager of 3 Jerusalem Place LLC,** has applied to the Board of Appeal to erect three similar five-story brick buildings, side-by-side on an existing parking lot. Each building will contain two duplex residential units and two ground-level parking spaces. The height to the roof line of each building will be 54 feet, and there will be no roof decks or balconies. This appeal is scheduled to be heard by the Board on Tuesday, November 28.
